Recommended Action : That the board approve the Superintendents recommendations to increase the teacher and instructional pay scale and to implement the incentive stipend package as presented beginning with fiscal year 2025-2026.

Public Content

The pay scale adjustment is an across the board salary increase for all teachers and employees on the instructional pay scale. This adjustment brings starting teacher salaries to \$50,000, which is more than \$2,000 greater than the starting salary in any other district in the area. This comprehensive incentive package includes: co-curricular incentive stipends, clubs and organizations stipends, playoff stipends, stipends for certain teacher assignments, and stipends for meeting certain student performance standards. Compensation for working extended seasons, compensation for work with student clubs and organizations, and compensation for teachers who teach classes with state assessments are all part of the plan to assist with the recruitment and retention of teachers for the Lafayette Parish School System. Throughout the development of this package, feedback was received from two teacher focus groups, four informational meetings at school sites, multiple advisory panels, and four days of public viewing via the LPSS intranet. These salary increases are from savings resulting from the Board-approved District Office Optimization and Consolidation and Staffing Adjustments. This money will now be used to help pay for higher salaries and stipends.

The current fiscal agent contract with First Horizon will expire on July 31, 2025. First Horizon has agreed to offer a two-year extension. The interest rate structure for interest bearing accounts would remain the same with a floating interest rate tied to the Federal Funds Upper Rate minus 30 basis points. The current Federal Funds Upper rate is 4.50%. Schools would continue to receive the benefit of no service charges on non-interest bearing accounts. Renewals are expected to continue and subject to negotiations and acceptance by both parties.

In March of 2025, the Federal Open Market Committee (FOMC) decided to maintain the target range for the federal funds rate at 4.25-4.50. The FOMC have signaled that they are open to two interest rate cuts during the calendar year, but will continue to assess incoming data, the evolving outlook of the economy and the balance of economic risks.

Despite the direction the FOMC will choose regarding interest rates, our bank interest rate will float with the market for optimal earnings.

Lafayette Parish School Board has control over a significant amount of Section 16 Property in Youngsville. The local and regional economic development entities, LEDA and One Acadiana, and LPSB would like to pursue development-ready certification for three tracts of land through the Louisiana Economic Development (LED) Certified Sites Program to market the sites to prospective lessees who may be interested in leasing and developing the site(s). This certification aims to result in economic development, creating jobs, capital investment, tax revenue, and greater lease revenues that will benefit Lafayette Parish School Board and the region.

Lafayette Parish School Board retains the right to market the sites to other potential lessees, independent of One Acadiana & Louisiana Economic Development (LED).

Louisiana Economic Development (LED) will cover 75% of the certification cost, with Lafayette Parish School Board, One Acadiana, LEDA, Slemco, and the City of Youngsville sharing the remaining 25%.

It is estimated that the Lafayette Parish School Board share of the cost for this certification is \$6,500.

The subject properties are appraised under the assumption that they meet the criteria to be certified by Louisiana Economic Development.
