Lafayette Parish School System requested Gallagher Benefit Services to market its pharmacy benefit program and assist in selecting a Pharmacy Benefit Manager (PBM) to meet the needs and objectives of the District.

Gallagher Benefit Services will provide a review of the Traditional Pharmacy Benefit Plan. This plan encompasses members who are not on Medicare. There were five PBMs that received and responded to the initial proposal. They included: the current incumbent RxBenefits (CVS Caremark), Louisiana Blue (Express Scripts), MedImpact, Meritain Health (CVS Health) and UMR (Optum Rx).

After reviewing the responses, the field was narrowed based on cost savings, formulary disruption, allowances/credits, performance guarantees and medical integration. The two PBMs that have been asked to provide a best and final offer are Meritain Health (CVS Health) and UMR (Optum Rx).
