Mr. Francis Touchet, Superintendent Lafayette Parish School Board Update 4.1 Mr. Francis presented a handout with the following information: Special Election for Millage Renewal of 7.79 Mills on All Property, Superintendent's Gumbo Cook-Off, Received Board Approval, AA+ Bond Rating from S&P Global Ratings, First Day of 25-26 School Year is August 7, 2025, LPSS Core Values, and Projects such as Southside High: stadium project on track to be ready to go for first game of the season. Katharine Drexel: restroom upgrades made to accommodate pre-K population. Broussard Middle: walkway canopies added. Billeaud Elementary: planning a walking track upgrade. Comeaux High: walk-in freezer and refrigerator replacement underway. Mayor Bourque asked Mr. Francis to provide an update on Katharine Drexel School. Mr. Francis stated that Katharine Drexel School has been converted into a Pre-K facility with 16 classrooms, each accommodating up to 20 children. The newly developed section is designed to support early childhood development with murals, seating, and learning tools to prepare students for kindergarten. It will serve Pre-K students from across the region and will be fully operational by August 7, 2025. Parents can enroll their children at little to no cost, offering a better alternative to daycare. Mayor Bourque asked Mr. Francis to prioritize a delayed sidewalk project near Martial Billeaud Elementary School, stating that there is the development of two new subdivisions that would benefit from improved pedestrian access. He expressed a readiness to move forward, partner with LPSS, and present the project to the council, requesting an update on its status. Mr. Francis confirmed he met with Graham from the City of Broussard and said he is currently ready to move forward,

and funding is not going to be any issue. He also asked that Graham reach out to him to discuss what is needed to move forward. Mayor Bourque expressed appreciation for Mr. Francis's willingness to collaborate and affirmed that the project would benefit local residents.



The City Council of the City of Broussard, Louisiana, meeting in regular session with a quorum being present on the 12<sup>th</sup> day of August, 2025, acted as follows:

- WHEREAS, the Lafayette City-Parish Consolidated Government (LCG) and BROUSSARD have an existing Wholesale Water Agreement with a forty (40) -year term, originally entered into on March 5, 1998 (the "Agreement"); and
- WHEREAS, The Agreement, among other things, provides that BROUSSARD shall, during the term of the Agreement, purchase water supply to serve all of its retail and wholesale customers within its corporate limits, as those limits may be expanded from time to time; and
- WHEREAS, the developer of Eola Place Subdivision (the Subdivision) has requested that the City of Broussard agree to sell water for provision to residents of the Subdivision; and
- WHEREAS, the Subdivision is located outside of the corporate limits of BROUSSARD and is unlikely to be incorporated into the corporate limits of BROUSSARD; and
- WHEREAS, LCG has agreed to amend the Agreement to allow sale of water for provision to the residents of the Subdivision; and
- WHEREAS, the City Council of the City of Broussard, Louisiana finds that it would be in the best interest and welfare of the citizens of Broussard, Louisiana, to amend the existing Wholesale Water Agreement with LCG to allow sale of water for provision to the residents of the Subdivision.

Therefore,

- **BE IT ORDAINED** that the City of Broussard, Louisiana shall enter into an amendment to the Agreement with LCG for the purposes set forth above; and
